- Concerns over inconsistent and incomplete information provided
- Concerns over Noise Nuisance which will affect neighbouring properties
- Concerns with regards to congestion on an already dangerous narrow road by commercial vehicles entering and leaving the premises.
- Concerns over where the Glamping Pitches are allocated as this will affect the open countryside scenery
- Concerns over the pedestrian safety
- Concerns over Agricultural tie conditions attached to the property. The property should remain as an agricultural working Farm

In addition concerns were raised about the possibility that an unlicensed dog breeding business may currently be operating from the site. Somerset West & Taunton District Council Planning Officer Jeremy Guise was asked to look into this.
