6 CREATION OF STANDING ORDER

7 GRANTS

To consider Q3 grant applications as received and detailed below. A summary is attached for information and the applications and their supporting documents have been circulated in advance of the meeting.

- (a) BLACK* Artists on the Move to consider an application for £3,000 toward the delivery of two Black History Month day workshops at each of the Wellington Primary Schools (8 days in total)
- (b) Grand Western Greenway to consider an application for £3,500 toward an engineering assessment and route definition.

 NB the Council has a budget line for 'Cycle Path Contributions' that currently has

no committed spend.

- (c) Wellington Rugby Football Club to consider an application for £2,000 toward their annual firework display.
 - NB the Council has a budget line set at £2,000 for 'Annual Fireworks'.
- (d) The People's Plot, t/a eat:Festivals to consider an application for £750 toward the annual eat:Wellington Event.
 - NB the cover letter of this application requests consideration of the creation of an SLA agreement to cover the annual event. The committee may wish to consider referring this application to the External Funding Working Group for further review. It should be further noted that this application refers to an event being held in September 2025 and therefore in the next financial year.
- (e) Life Education Wessex to consider an application for £290 toward delivery of the 'Helping Children Make Healthy Choices' workshop at Rockwell Green Primary School in 2024.
- (f) Wellesley Park Primary School to consider an application for £1,085 for a morning food/breakfast scheme.
 - NB a similar initiative at Beech Grove has been funded in the current financial year from the Cost of Living Fund reserve.
- (g) Community Council Somerset to consider an application for £1,150 toward cost of the Wellington Together event.
- **(h) Accelerate Active** to consider an application for £2,858 toward the provision of Blaze Pods, Climb Wall Indoor Pannels and Safety Mirrors.
